BROWN COUNTY, MINNESOTA

The regular meeting of the City Council of the City of Sleepy Eye was duly held in the Council Chambers, 200 Main Street East, Sleepy Eye, MN on the 13th day of February 2024 at 7:00 pm, per due call and notice.

Mayor Wayne Pelzel and Councilors Nathan Stevermer, Douglas Pelzel, and Scott Krzmarzick were present. Councilors Gary Windschitl and Christina Andres were absent.

M/Stevermer, S/Pelzel to approve Resolution 4-2024, A Resolution Accepting Donations to the City of Sleepy Eye. Motion carried 3-0.

M/Pelzel, S/Krzmarzick to approve Resolution 5-2024, City approval of County Project 008-633-004 within Municipal Corporate Limits; Resolution 6-2024 Resolution for No Parking; Resolution 7-2024 Approving County Project 008-634-012 within Municipal Corporate Limits; and Resolution 8-2024 for Parallel Parking Only.
