Vendor Cost for 2024:

\$150.00 for 2024 Season

- This is a one-time fee to be in the Market for 2024.
- Market Fee of \$150.00 due prior to May 24, 2024
- Just over \$7.00 per Saturday if you attend all 21 dates.
- No required attendance, however the more vendors each day the more attractive to buyers
- No Single or Daily Market Fees to be Collected in 2024
- Does not include Summerfest Saturday Location for that Saturday is Allison Park Contact Chamber Office for Details
- Checks made payable to Sleepy Eye Regional Foundation
- Drop or send payment to Sleepy Eye City Hall (200 Main St. E. Sleepy Eye, MN 56085)
- Would like to see a minimum of at least six vendors for the season.

Vendors need to be sure that they clean up their selling areas at the end of the Market each day before they leave the location.



### Sleepy Eye Vendor's & Farmer's Market Rules/Regulations - 2024

- ♣ The Market will be open every Saturday morning (9:00am Noon) during the season. June 1, 2024, through October 26, 2024 (weather permitting).
  - June 1, 8, 15, 22, 29

July 6, 13, 20, 27

- August 3, 10, 24, 31 (August 17, Summerfest Vendors at Allison)
- September 7, 14, 21, 28

October 5, 12, 19, 26

- The vendor's fee is \$150 for the season to be paid prior to May 24, 2024. (Checks made payable to the Sleepy Eye Regional Foundation) Vendor's fee is non-refundable.
- Vendors should set up 30-45 minutes before 9:00AM start time.
- → The Market will be located in the Schutz Family Foods parking lot on the south end in front of the grassy area between the two driveways. (See map)
- Products offered for sale are listed on the attached list. Processed, canned, and baked foods must be labeled with the name of the vendor preparing the foods, marked with the date of preparation, and the phone number of the vendor. Signs must be prominently displayed stating these foods are home prepared. The exact wording is "These foods are homemade and not inspected".
- Vendors are responsible to provide their own mechanical or electrical freezer and/or refrigeration equipment. No electricity will be provided.
- Vendors are responsible for daily cleaning up their selling area after the Market closes.
- All vendors should be respectful of all other vendors and shoppers.
- No pets allowed.
